THE 31st ANNUAL BAZAAR CONTRACT

Brush Creek Youth Ranch Teen Challenge does hereby invite you to participate in the Annual Brush Creek Bazaar and Fall Family Festival. Payment for your exhibit space and table rental must accompany this contract. Refunds will be made ONLY if unforeseen circumstances force the show to be canceled by Brush Creek Youth Ranch Teen Challenge of Oklahoma. **If the exhibitor cancels after September 1, 2009 no refund is made.**

BRUSH CREEK YOUTH RANCH TEEN CHALLENGE OF OKLAHOMA AGREES TO:

1. Conduct an attractive and efficiently managed show.
2. Extensively publicize the show through numerous mailings, posters, television, radio, newspaper and magazines.
3. Furnish twenty-four (24) hour security for the show premises from Thursday evening until Sunday evening. The provision of such security shall in no way commit Brush Creek Youth Ranch Teen Challenge to any responsibility for loss and damage to the Exhibitor's property or person, whatever the cause.
4. Furnish to the Exhibitor name badges and (2) parking passes. Due to the limited space, Exhibitors will be allowed only 2 vehicles in the Exhibitor's Parking Lot at any time (trailers are considered a separate vehicle and will require a parking pass). Each vehicle will be furnished with a 3-day pass to be displayed on the rear-view mirror and an Exhibitor Parking card to be visibly displayed on the dash of each vehicle or trailer and remain in place throughout the Bazaar. **Vehicles and trailers in the Exhibitor's Parking Lot without the Exhibitor's parking passes visible at all times will be subject to towing and a \$25 fine.**
5. Send a committee member to visit each Exhibitor space prior to the opening of the show to insure that, in the opinion of the committee, each space is set up in good taste and meets the standards of good quality maintained by the Bazaar. **Any item not in accordance with these standards must be removed by the Exhibitor.**

THE EXHIBITOR AGREES TO:

1. Read and understand the terms of the contract before signing.
2. Correctly represent articles offered for sale, all of which must be hand-crafted and/or hand-decorated or other wise approved by the committee. The Bazaar Committee reserves the right to deny space and/or make exceptions for an Exhibitor in violation of this or any other rule.
3. Not transfer this Contract nor share space without prior approval.
4. Must maintain booth throughout the show unless specific arrangements are agreed upon prior to executing this contract.
5. Keep your entire display within the size contracted for and within the boundaries assigned. Anyone not adhering to this requirement may be asked to leave.
6. Exhibitors must provide table covering to reach the floor for each table. Merchandise or packing boxes may be under tables but must not create an unsightly view or be exposed in any way.
7. Maintain an attractive exhibit throughout the tenure of the show and at no time leave your booth unattended. Assistance will be provided as needed.
8. Move into your exhibit area at our assigned time between 9:00 a.m. and 4:00 p.m. on Wednesday, September 30th & Thursday, October 1, 2009. No taking down or packing up of exhibits is allowed until Saturday, October 3rd at closing time of festival.
9. **FOOD VENDORS MUST BE SET-UP BY 10/1/09 & AVAILABLE FOR THE HEALTH DEPARTMENT INSPECTION AT 2 PM!!!** We will not duplicate food items from multiple vendors.
10. **NO ALCOHOL. PETS OR SMOKING IN THE SHOW AREA.**
11. Contribute a fifteen percent (15%) tax-deductible commission on **TOTAL GROSS SALES.** **A commission of 15% will be collected daily from each exhibitor ~ NO EXCEPTIONS!**
12. I agree to include a minimum of (3) good photos of my work which will not be returned (photographs/digital submissions on disc, EMAIL ACCEPTED; All types of items you wish to sell with price range as well as a photo OR detailed description of your over all booth display, stamped self-addressed #10 envelope and a short resume or artist statement on your career as an artist or craftsman.
